
Reviewing Client Feedback

Understanding what does and does not work for our program participants is important. If we want to be conscientious practitioners of restorative justice, we must seek feedback and reflect on it once given. The information provided by our program participants can guide us toward ways to improve our practice and identify where we're already successful.

. As we reflect on this data it's also important to note that of the 41 folks we've worked with in the last year only 11 consented to fill out the feedback form.


These answers reflect a sample size of 27% of all program participants.

Question: I feel like I have made amends for the harm I have done.





Question: I feel the restorative process helped me resolve this incident and move forward with my life.





Question: The Justice Center staff & community members helped make it comfortable to talk freely.



Question: In your view, what was the most valuable part of the restorative justice process?

"Realizing how many people were affected."

"Being honest with myself, the staff and community members."

"Having a chance to have my voice heard and explain how the event affected my life."

"the process was handled in such a way that I was able to feel comfortable sharing my story in a safe environment"

Question: Are there additional thoughts you would like to share?

"The process separated my actions from who I know I am as a person, and gave me further confidence to pursue my course of recovery in a constructive way."

"For people coming after me - be patient, reliable, and honest."

"I really appreciated that the panel made me feel comfortable and never judged. It made it easier to share with them and be honest."
